

**Proceedings of the 10<sup>th</sup> Statutory Meeting of The Odisha State Commission  
for Protection of Child Rights held on 18.1.2016**

1. At the outset the Chairperson welcomed all the Members to its 10<sup>th</sup> Statutory Meeting and wished that the Commission shall continue with the same enthusiasm and vigor in performing its duty towards the children for their best interest.
2. The Chairperson deliberated on the issues to be taken up for the next months before the end of the Financial year. The Action taken Report on the decisions taken in the last Statutory Meeting was reviewed and confirmed.
3. It was decided that as per the mandate of CPCRA Act and Rules as the Commission is the monitoring agency of JJ Act, POCSO Act and RTE Act, one RTE Cell utilizing the funds from OPEPA is to be opened in the Commission in consonance with the National Commission and other State Commissions. In this regard Kerala Commission may be consulted. For the cell, all the infrastructure and engagement of staff on temporary basis be made accordingly. A proposal and budget plan to be put up by the Member Secretary.
4. It was decided that two camp courts to be held on 4<sup>th</sup> February 2016 at Cuttack and 9<sup>th</sup> February 2016 at Puri District.
5. It was decided that the Members shall visit Nirakarpur, Jagatsinghpur and Taxshila Schools in connection with the cases.
6. It was decided that on 5<sup>th</sup> February 2016 and 10<sup>th</sup> February 2016 there shall be two District level workshops on sensitization of field functionaries of School and Mass Education Department on RTE Act, JJ Act and POCSO Act. The detail program to be chalked out and put up.
7. It was decided that the Members shall visit the <sup>Observation</sup> ~~Juvenile Justice~~ Homes and Special Homes preferably on the days of sitting of CWCs.

8. It was decided that a letter under the signature of the Chairperson to be issued to the Department on shifting of office to Toshali Plaza or a suitable place.
9. It was decided that during field visits of the Members/Officials if a meeting is held, the DCPOs shall be reimbursed an amount of Rs 100/- per person who attends the meeting towards providing one working lunch and two teas with snacks on production of vouchers.
10. As per the mandate of the CPCR Act and norm followed in other Commissions, the Audit Report conducted by the Chartered Accountant engaged shall be included in the Annual Report of the Commission henceforth.
11. It was decided that the Annual Report 2014-15 and 15-16 may be prepared so that it can be placed in the next Assembly Session.
12. As its not possible to subscribe to all the editions of all the news papers of Odisha, it was decided to write to the DCPOs to intimate the Commission as and when any issues of violation of child rights come up in the local media..


